Though his parents hail from Kilkenny, Kevin was born and raised in London in the 1950s. Both parents knew poverty as children, so Kevin was raised with a deep appreciation for people who struggle.

Kevin still remembers his earliest memories of Oxfam. "I think my first encounter with charities was when I was in school. I was aware of Oxfam more than other charities. Everybody knew Oxfam."

As a young man, Kevin travelled the world before moving to Ireland. On a trip to South America, he developed a heartfelt belief that what you have, you share with those who have less.

#### "I think there's a touch of philanthropy in most people,

they want to help. Maybe they feel they can't change things. But it isn't hopeless. It's only hopeless when people stop responding at all."

Thankfully, Kevin never stopped caring, he never stopped responding, and he never stopped fighting for fairness.

"As we got older, we were sitting down thinking, "What's going to happen when we're not here anymore?" We don't have children, so the option of leaving some money to charity came into the equation.

So, we left a gift to Oxfam in our Will. Oxfam know where the need is going to be, so they can decide what to do with it. If people can be enabled to help themselves, if the resources are put into tools and animals and crops, then they can lift themselves up."

Searing heat has caused an unrelenting drought in East Africa, threatening the lives and livelihoods of millions of people. But today, more and more compassionate people like you are showing their commitment to fighting climate injustice by leaving

gifts in their Wills to Oxfam.

Ngaremara Village in Eastern Kenya, is an example of the kind of project a gift like yours could go on supporting for decades.

As Catherine Bahati, treasurer of Ngaremara's water committee told us, "We have to walk for long distances to fetch water. Our parents did it, their parents did it and now we are also experiencing the same fate. We don't want our children to go through the same thing."

Thanks to a gift left by someone like you in their Will, projects like the one in Catherine's community can ensure people no longer go to bed wondering whether they will have clean water tomorrow. "We depend entirely on keeping and rearing livestock. When we lose our livestock due to lack of water, we are left stranded."

It's amazing to think that the vision of one kind-hearted person like you, can empower someone like Catherine to lift herself, her family, and her community out of poverty and injustice, so generations never have to experience what hers has.

That's the power of leaving a gift to Oxfam in your Will. The fact that you never have to stop fighting for fairness, means communities like Catherine's never have to fear dying of thirst or hunger again.

### 1942

Relief raises funds for war refugees and lobbies the British government to allow vital food and medical supplies through a blockade and into Greece.

#### 1960

By the 60's, The Beatles were joining the fight, supporting Oxfam's Freedom from Hunger The Oxford Committee for Famine Campaign for the Congo during World Refugee Year. It was also the year that the Bewley family, known for their cafés, became Oxfam supporters, helping to launch a wave of support across Ireland.



#### 1972

Oxfam's first shop in Ireland opens on South King Street in Dublin. The following year, Oxfam Ireland officially comes into being, and an RTÉ radio appeal for Ethiopia raises £10,000.






#### 1990

We all remember Mary Robinson becoming the first female president of Ireland, a hugely important social and political milestone. But her appointment as Honorary President of Oxfam in 2002, after she finished her term, marked an equally important milestone for us.

#### 1994



Supporters help Oxfam mount its largest humanitarian response following the genocide of an estimated 800,000 people in Rwanda, helping millions fleeing the region.





In Timor-Leste - where 70% of the population were struggling without enough to eat for at least one month a year - Oxfam helped farmers introduce a new farming technique to prevent soil erosion. Crops were no longer washed away during the rainy season, bringing communities food security for the first time.

#### Across Ireland we were all still celebrating Christmas when the devastating tsunami struck. Do you remember where you were when you heard the news? In response, wonderful Oxfam Ireland supporters like you raised a staggering €1.6 million to help the survivors.



#### 2023

Oxfam Ireland turns 50 marking five decades of impact, including a major response to the growing humanitarian crisis in Gaza. Working through local partners, by the end of 2024 we've helped over 73,000 people with their most urgent needs and the work continues.

#### SUGGESTED WORDING

You may like to share the following paragraph with your solicitor, which has been drafted specially for this purpose:

I GIVE the sum of  $[\pounds/E] xx$  (sum in words) to Oxfam Ireland [Republic of Ireland Registered Charity Number (RCN): 20009946 / Northern Ireland Charity Commission Number: NIC100848], for its general purposes. of the said charity and I direct that a receipt by the treasurer or other proper to such charity as they consider officer of the said charity shall be sufficient discharge for my executors

in the payment of this legacy. If, at the date of my death, the said charity has ceased to exist or has amalgamated or become incorporated with another charity or has changed its name, then this legacy shall not fail, but my executors shall pay the legacy most nearly fulfils the objects of that which I intended to benefit.
